## How long should I hold it and can I take money out early?

### **Recommended holding period: 10 years**

The recommended holding period (RHP) has been calculated in line with the investment strategy of the Sub-Fund and the timeframe in which it is expected that it will be possible to achieve the investment objective of the Sub-Fund.
