

Performance Scenarios

What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted. The unfavourable, moderate, and favourable scenarios shown are illustrations using the worst, average, and best performance of the product / a suitable proxy over the last 15 years. Markets could develop very differently in the future.

Recommended holding period: 10 years

The unfavourable scenario at 10 years occurred for an investment in the product/applicable proxy between January 2025 and January 2026.

The moderate scenario at 10 years occurred for an investment in the product/applicable proxy between July 2015 and July 2025. The favourable scenario at 10 years occurred for an investment in the product/applicable proxy between December 2011 and December 2021.

What happens if Mediolanum International Funds Limited is unable to pay out?

What are the costs?

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and the performance of the product. The amounts shown here are illustrations based on an example investment amount and different investment periods. We have assumed:

- In the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.
- EUR 1.000 per year is invested.

How long should I hold it and can I take money out early?

Recommended holding period: 10 years

The recommended holding period (RHP) has been calculated in line with the investment strategy of the Sub-Fund and the timeframe in which it is expected that it will be possible to achieve the investment objective of the Sub-Fund. The investor has the right to totally or partially redeem the contract on any valuation day, collecting the redemption value calculated based on the value of the shares of the Sub-Fund on the date the request is received by the Manager, without any redemption fee being applied. We recommend that you hold the investment at least until the end of the recommended holding period in order to fulfil the objectives of this product. This product may not be suitable for investors who plan to redeem their contract before the end of the recommended holding period. The product does not provide any guarantee of return on the expiration of the recommended time horizon, and any redemption before that date may compromise the investment performance.
